Disabled Persons Parking Places  
Order 2014**

**NOTICE** is hereby given that the Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulations Act 1984 and all other enabling powers and after consulting with the Chief Officer of Police have made the above Order the effect of which will be:

To restrict on-street parking to blue badge holders only, in a clearly marked out bay on the highway in the vicinity of the properties indicated below:

- a) 5 Ramsden Street, Rhymney
- b) 7 Western Terrace, Crosskeys
- c) 16 Cobden Street, Crosskeys
- d) 11 Central Street, Pwllypant

It is also proposed to revoke the disabled persons parking places at the following addresses:

- a) 25 Beulah Street, Rhymney
- b) 41 Waunfawr Gardens, Crosskeys
- c) 22 North Road, Pontywaun
- d) 4 Lewis Street, Machen
- e) 229 Elm Drive, Ty Sign, Risca

The Order shall come into operation on the 27th of June 2014 as the associated signs and road markings will be in place.

If you wish to question the validity of the Order or any of the provisions in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 on the grounds that any requirement made under the Act has not been complied with in relation to the Order, you may within six weeks of today's date apply to the Court for this purpose.
