**Blackwood and Cefn Fforest Prohibition & Restriction of Waiting Order 2014**

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of their powers under the Road Traffic Regulation Act 1984 and all other enabling powers and after consulting with the Chief Officer of Police have made an Order the effect of which is to:-

1. Prohibit waiting at any time on;
  - a) Elgar Close and Fair View junction
  - b) Cwrt Glanhowy rear access
  - c) Rhosnewydd Terrace/Gordon Road rear access
  - d) Section of William Street eastern side
  - e) Montclair Avenue outside properties 24 & 26
  - f) School Way junction with Ty-Isha Terrace
2. Revoke prohibition of waiting on;
  - a) Section of Twynnyffald Road
  - b) Sections of William Street
  - c) Sections of Ty-Isha Terrace
3. High Street section of existing limited waiting to be replaced with disabled badge holders only parking
4. High Street section of loading only to be replaced with prohibition of waiting and no loading restriction
5. Woodbine Road disabled badge holders only to be replaced with limited waiting Monday to Saturday 8am – 6pm 30 minutes no return within 1 hour
6. Woodbine Road prohibition of waiting except taxis 6pm – 8am and disabled badge holders only 8am – 6pm for times shown to be replaced with limited waiting Monday to Saturday 8am – 6pm 30 minutes no return within 1 hour
7. William Street section of limited waiting to be revoked
8. Ty Isha Terrace prohibition of waiting Monday to Friday 8am – 6pm to be replaced with prohibition of waiting at any time
9. Limited waiting 30 minutes no return within 1 hour Monday to Saturday 8am – 6pm to be introduced near the junction of Elgar Close and Fair View
10. Revoke existing prohibition of waiting at any time to extend existing bus stop clearway on Bedwellly Road
11. To revoke Blackwood and Cefn Fforest Prohibition & Restriction of Waiting Order 2012

The Order shall come into operation 27th June 2014 or such date as the associated signs and road markings are in place.

If you wish to question the validity of the Order or of any of the provisions in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 on the grounds that any requirement of that Act made under it has not been complied with in relation to the Order you may within six weeks of the date hereof apply to the Court for this purpose.

2. Dileu y gwaharddiad aros ar;
  - a) Rhan o Heol Twynnyffald
  - b) Rhannau o Stryd William
  - c) Rhannau o Deras Ty-Isha
3. Y rhan o'r Stryd Fawr lle mae aros cyfyngedig ar hyn o bryd i gael ei newid i fod ar gyfer deiliaid bathodynau anabl yn unig
4. Y rhan o'r Stryd Fawr lle mae llwytho yn unig i gael ei newid i fod â gwaharddiad aros a dim llwytho
5. Heol Woodbine deiliaid bathodynau anabl yn unig i gael ei newid i fod yn amser aros cyfyngedig Dydd Llun i Ddydd Sadwrn 8am - 6pm 30 munud a dim dychwelyd o fewn 1 awr.
6. Heol Woodbine gwaharddiad aros heblaw am dacsis 6pm - 8am a deiliaid bathodynau anabl yn unig 8am - 6pm i newid yr amserau presennol i fod yn amser aros cyfyngedig Dydd Llun i Ddydd Sadwrn 8am - 6pm 30 munud a dim dychwelyd o fewn 1 awr.
7. Dileu amser aros cyfyngedig ar ran o Stryd William
8. Gwaharddiad aros ar Deras Ty-Isha Dydd Llun i Ddydd Gwener 8am - 6pm i newid i fod yn waharddiad aros ar unrhyw adeg
