For public events organised by Caerphilly County Borough Council in the town centre of Caerphilly to include the performance of plays, films, live music, recorded music, performance of dance, anything of a similar description, making music, dancing, entertainment of a similar description and supply of alcohol. Where the Supply of alcohol could between 09:00 and 21:00 hours and regulated entertainment could be between 09:00 and 22:00 hours depending on the event.
